GENERAL APPLICATION STRATEGIES: FytoFert-S is a liquid fertilizer containing sulfur. Due to the sulfur hydrophilic nature, FytoFert-S leaves less residue on the plant. FytoFert-S is easy to use.

APPLICATION METHOD: Apply 0.32 - 0.64 gal/acre, depending on the crop. Apply in sufficient water volume to ensure thorough coverage. Maximum number of applications per season is 7. Seek the advice of the county agricultural representative or a professional agricultural consultant for further information.
